BATH AND SPA RULES

- 1. smoking is prohibited on the entire area of the Bellavita Adventure Pool and Spa.
- 2. the use of the whole complex is in any case at your own risk.
- 3. the municipality of Pontresina is not responsible for stolen or lost items. Lost and stolen items must be returned to the cashier.
- 4. swimming lessons and other courses require a permit.
- 1.
- 5. school classes, groups, etc. may only visit the pool under the guidance and accompaniment of an adult accompanying person, one accompanying person per 12 persons.
- 2.
- 6. the pool staff is entitled to reserve parts of the pool for schools, clubs and courses, etc. and to delimit them accordingly.
- 7. children under the age of 8 and those who cannot swim are only allowed to enter when accompanied by an adult (adult = 18 years). Teenagers under 16 years of age, unaccompanied by adults, must leave the indoor swimming pool no later than 20.00 hours. No responsibility is taken for unattended small children.
- 8 The opening hours are posted at the entrance. 30 minutes before closing time, the entrance to the swimming pool will be closed.
- 9. entering the indoor swimming pool is only allowed with bathing clothes.
- 10. shower is obligatory before bathing.

- 11. is forbidden:
- a. to enter the wet rooms with shoes
- b. stay unnecessarily long in the checkrooms, showers and toilets
- c. remain unclothed outside the checkrooms
- d. to contaminate the installation and the pools
- e. to eat, drink and chew gum in the checkrooms and at the pools
- f. to consume alcohol in the entire bathroom area
- g. To let toddlers play and bathe without swimming trunks
- h. for non-swimmers, entering the swimming pool
- i. diving with respirators without special permission
- j. pushing people into the pool
- k. To dive down with the bathers
- I. Ball games with hard balls
- m. to swim across the lanes
- n. using the slide against the regulations
- o. running in the whole building
- p. photographing people without their permission
- q. bringing and playing music equipment
- r. entering and using the bathing facility outside of the operating hours
- 12. jumping in from the long sides is prohibited.
- 13. jumpers must convince themselves that the jump can be performed without endangering other bathers.
- 14. it is forbidden to swim underneath the jump.

15. people with skin rashes, open wounds or infectious diseases as well as drunk and unclean people are not allowed to swim.

16. people suffering from temporary health problems may use the bath only when accompanied by an adult supervisor.

17. subscriptions, annual and season tickets are personal and non-transferable, they must be deposited with name, surname and address.

18. discounts for locals from Pontresina and partner communities can only be granted on presentation of a valid local identity card.

19. lost tickets will not be refunded. Lost personal subscriptions, annual and season tickets can be reissued for a fee of CHF 20.

20. the bath remains closed during the revision work.

21 In the event of loss of a chip bracelet, a compensation of CHF 50.00 will be charged.

22. the wishes and complaints of bathers must be submitted in writing to the management.

23. bathing regulations, information boards and instructions of the bathing staff are binding. Furthermore, bathing guests who behave improperly or give cause for complaint may be expelled from the pool by the pool staff after a warning. Order, safety and good manners must be observed.

24. every guest has to take the entrance ticket for the abovementioned bathing rules. Violation of these rules may lead to immediate expulsion from the bath after a warning. In case of recurrence or gross violations the management has a limited or permanent ban on admission. For damages and contamination the guilty parties are liable, in case of minors their parents or legal representatives.

25. parts of the bathing facility are monitored by video (no checkrooms, toilets, etc.)

26. the use of cell phones, smartphones and other recording devices is prohibited on the entire spa area.
